**Student expenses for the practitioner education program include:**

Application Fee - **\$25.00** (due with application)

Tuition - **\$3,750.00** (includes 14 lunches and 11 dinners)

Textbooks and Student Materials Fee - **\$500.00** (due upon acceptance into program). The textbook and student material fee is necessary to reserve space for entry into the program. This fee is refundable until two weeks prior to the commencement date of the course with the return of textbooks that have already been sent to prospective students.

Teaching supplies for 18 clients – Includes introductory session PowerPoint CD (**\$100**) and teaching supplies for the required **18** clients (approximately **\$15** per client) plus shipping and handling charges. The student will be billed for these materials from the Pope Paul VI publications department. These costs can be passed onto clients.

On-Site Visit Expenses – an on-site visit will be conducted at the student's location during the second practicum. Costs to the student include travel (mileage or airfare), food and hotel room for one night for the student's Supervisor. All on-site visit expenses are payable at the time of the on-site visit.

Travel and Accommodation Expenses – as determined by the student. There are numerous hotels in the area. Hotel recommendations and special rates will be provided upon request.
